AQUENCE GL 3173 is ready to use and shall not be diluted.

#### Cleaning

Clean up wet or dry adhesive with soap and warm water (max. 40°C).

#### STORAGE

Rotate stock, using oldest material first. Protect from freezing. Keep container covered when not in use to prevent moisture loss and contamination. Do not mix with other adhesives. Optimum storage temperature: 15 to 25°C

#### Shelf life:

Shelf-life (in unopened original packaging), months 9 Refer to expiry date on original packaging.
